The housekeeping portion of this position is responsible for the oversight of client bedrooms, nightly cleaning checklist and ordering of housekeeping supplies.

Under the supervision of the Clinical Program Manager and/as part of the various workgroups and teams, the Clinical Cook/ Housekeeper performs the following services within the framework of the CJAHC core policies, functions and for the provision of essential services to client

Responsibilities

- Follow safe food handling including temperature checks and ph. levels
- Plan, prepare, and serve food within menu guidelines and dietary requirements of clients and by following the Canada & Aboriginal Food Guide
- Ensure that food is ready to be served at required times
- Prepare food plans and the ordering of foods supplies Keep kitchen and eating areas clean at all times
- Regularly maintain food storage facilities and equipment
- Ensure all dishes, pots, cutlery and regularly used items are cleaned and sanitized daily and at the end of each program

- Responsible for the oversight of client bedrooms at the beginning of each block treatment program, nightly cleaning checklist and ordering of housekeeping supplies
